

## HomeServe 15<sup>th</sup> Anniversary Sweepstakes OFFICIAL RULES

**NO PURCHASE OR ENROLLMENT NECESSARY.** The HomeServe 15<sup>th</sup> Anniversary Sweepstakes (the "Promotion") is open to legal residents of the fifty (50) United States and the District Of Columbia, who are of legal age of majority in their state of residence (18 (except Alabama and Nebraska residents must be at least 19 and Mississippi must be at least 21)). Employees (and their immediate families [parent, child, spouse or sibling and their respective spouses, regardless of where they reside] and those living in their same households, whether or not related) of HomeServe USA Corp. ("Sponsor" or "HomeServe"), and its respective parents, affiliates, and subsidiaries and participating vendors/agencies are not eligible to enter or win.
